- Any person serving as a member of the United States Armed Forces on Active Duty, and all members of the Florida National Guard and United States Reserve Forces will have their application processed within 7 days. **** Copy of ID required.

If application is submitted incomplete, it will be held unapproved until the rest of the required information is received. Owners are responsible for their tenants and completion of all applications.
